Frank Sprunger of Berne, who is employed at the Central Soya Company at Decatur, was severely and painfully injured while at work Friday night. Sprunger operates a hammer mill in one of the buildings and while changing screens in the mill a belt struck him on the left side of the head. He was rendered unconscious and was taken to the Adams county hospital where he is said to be in severe pain.

The entire left side of his face was badly bruised and lacerated and his left eye severely injured. He is suffering hemorrhages in his eye and grave fears are held that he may lose his sight in that eye.
