Katherine M. and Jacob M. Schwartz, daughter and son of Mr. and Mrs. Jacob Schwartz, who lost their lives Sunday night in an auto-buggy crash north of Berne were buried this morning in the Amish cemetery near their home amid all the ceremonial rites symbolic of the Amish faith.

The road for a mile north and south of the Schwartz and Aaron Zook home, two miles east of road 27, was blocked by the scores of autos and rigs, carrying those who attended the services. Amish from Davis county near Elkhart and Allen county came to the Schwartz home this

morning to attend the services. A handful of Adams county residents attending their first Amish funeral swelled the number.

The bodies were kept at the Schwartz home where Joseph A. Schwartz Amish bishop, conducted the service in high German, while another preacher of the religious sect preached

the sermon at the Zook home. Both homes were filled to capacity. The Amish have no church

In accordance with Amish custom, they conducted their own funeral services, requiring the services of a Berne undertaker only to embalm. The children lay in hand made, plain, wooden caskets, stained to a darker color. The caskets were not lined but a pillow lay beneath their

After two hour services, a wagon carrying the caskets headed the funeral cortege to the Amish cemetery, located east of federal road 27, north of Berne. In burying the pair, wooden rough boxes, also hand made, were used.

All of the Amish were garbed in their habitual costume, fastened by hooks and eyes instead of buttons. The men wore black, flat brimmed hats with black flowing coats and capes. The women wore dark dresses and capes similar to those used for everyday wear.

VERDICT WITHHELD

J. Jerome Yager, of Berne, Adams county coroner, stated this morning that he was withholding his verdict until he could conduct a more thorough investigation. Harry Roth, 19, driver of the car involved in the crash, is at liberty under \$500 bond after pleading not guilty to a reckless homicide charge.

A survey disclosed that the last fatal accident in the county involving a buggy occurred north of Berne on October 24, 1931. Raymond Ross Benner, of Fort Wayne, driver of the auto lost his life in that accident. There have been a number of accidents since that time involving rigs, which did not result in a fatality.

Dr. C. H. Suckau, pastor of the church, performed the ceremony in the presence of a large assemblage of relatives and friends. The double ring service was used.

A program of nuptial music was presented by Miss Ruth Liechty at the organ, and vocalists, Miss Lorraine and Edward Burkhalter and Florence Habegger. Miss Liechty played a fifteen minute recital followed by the following selections in vocal numbers: "I Love You Truly" by Edward and Lorraine Burkhalter; "O Promise Me" by Florence Habegger and Lorraine Burkhalter and "Because" by Edward Burkhalter. The bridal chorus from "Lohengrin" was played for the processional just after the candles were lit and Mendelssohn's wedding march was used for the recessional.

The ushers were Kenneth Neuenschwander, James Von Gunten, cousins of the bride, Lew Hartman and Max Bahner, the latter two of Monroe.

Miss Vera Neuenschwander, sister of the bride, was bridesmaid. She wore a sheer pink dress trimmed in blue with the shoulders shirred. With it she wore a locket which was her gift from the bride, and she carried a boquet of Token roses.

The bride entered with her father by whom she was given in marriage. Her gown was of white satin with a long train and closed in the back with buttons from the neck to the waist. Her fingertip veil was trimmed all around with lace. She carried a bouquet of gardenia, freezia, white and blue grape hyacinth. She wore a two-strand necklace of pearls which was her gift from the groom.
