Dr. James M. Miller, 79, veteran Decatur physician, and one of the county's most revered citizens, died this morning at 8:52 o'clock at his home on South Second street.

Death was attributed to complications and heart trouble following an illness of about three years. He had been seriously ill for the past several days.

three years. He had been seriously ill for the past several days.

Dr. Miller was born in Celina, Ohio, February 14, 1861, the son of Dr. Milton M. and Susan Noble-Miller. He received his medical diploma at Wooster University in Cleveland and later was graduated from Ohio Medical university at Cincinnati. In 1892 Dr. Miller was married to Sadie M. Archbold. He was prominent in medical and civic circles of the city and county. At one time he served as a member of the city

council, and later was named city health officer.

For 17 years he served as county health officer, a position to which he dedicated his life and knowledge of the medical profession, making that office an opportunity to serve the people of the county and educate the citizens in the importance of proper

sanitation and the observance of the fundamental principles of health.

He was a faithful and active member of the First Methodist church here. Fraternally he was affiliated with the Knights of Pythias and Odd Fellows lodge of the state and county medical association. He was a past chancellor of the Knights Of Pythias and a past noble grand of the Odd Fellows.

He had been practicing in this city since 1897, specializing in eye, ear, nose and throat treatment.

**Funeral Monday** Funeral services will be held Monday afternoon at 1:30 o'clock at the home and 2 o'clock at the First Methodist church with Rev. R. W. Graham officiating. Burial will be in the Decatur cemetery.

His widow is the only living near survivor, other than nieces and nephews. Two

daughters, two sons, two sisters and a brother preceded him in death.

The body will be returned to the home from the S. E. Black funeral parlors Saturday and may be viewed there after 7 p.m. until time for the services. The casket will not be opened at the church.
