### MARK GOLDEN WEDDING ANNIVERSARY

(Photo) Saturday will be the golden wedding anniversary of Mr. and Mrs. Theodore Thieme, natives and residents of Union township, northwest of Decatur. The event is to be observed by a special church service, a dinner for the immediate family and an open house Sunday.

The church service will be held at the Bleeke Immanuel Lutheran church in Union township at 1:30 o'clock sun time, Sunday afternoon. This service, open to the public, is to be conducted by Rev. Harry Kruckeberg, of Striker, O., former neighbor of the Thieme family. Late in the afternoon the immediate family of the couple will meet at the Theodore Thieme home for a supper, which is to be followed by an open house for friends from 7 to 9 o'clock.

Although the parents of both Mr. and Mrs. Thieme were born in Germany, each was born in Union township. Mr. Thieme was born February 13, 1868, the son of Andrew and Christine Kruckeberg Thieme. Mrs. Thieme was born September 8, 1870, the daughter of Christ and Caroline Kruckeberg Schamerloh. Her name before her marriage was Miss Caroline Schamerloh.

As children Mr. and Mrs. Thieme were neighbors and friends, attending the parochial and township schools of Union township. They were both members of the Bleeke church.

The couple was the last to be married in the old Bleeke church, which stood near the site of the present building. The ceremony took place April 27, 1890, and was performed by the late Rev. William Schmidt, pastor of the church at that time.

After the marriage the couple lived for a few years with Mr. Thieme's foster parents, Mr. and Mrs. Abraham Studler in Union township. Later, Mr. Thieme purchased 40 acres of land in the township to which he has since added 40 more. For many years he farmed not only his own 80 acres, but the 80 acres of his foster parents.

Twenty years ago Mr. Thieme retired, and he and his wife moved to Decatur where they lived for five and a half years, however they preferred life on the home farm to that in the city and moved back to their Union township home. The farm is now operated by his sons.

Mr. Thieme has been active in church life, having served as trustee and at the present time is one of the elders of the Bleeke church.

Seven children were born to the couple, two of whom died in infancy. One son died at the age of 21 and had not married.

The four surviving children each have two children and are: Anton, whose sons' names are Gilbert and Elzey; Edwin, whose children's names are Melvin and Eileen; Mrs. Gertrude Grotrian, whose sons are Frederick and Arnold, and Mrs. Edna Grotrian, whose sons are Lester and Carlton. There are no great grandchildren.

Mr. Thieme's half-brother, August Thieme, and his wife, and his half-sister, Mrs. Clara Struempler, and her husband, all of Nebraska, are planning to attend the services and family gathering Sunday.
