Chester C. Byerly, 33, a native of Adams county, committed suicide at his home in Ossian Sunday evening.

Byerly, who had operated a restaurant at Ossian for the past three years, left his place of business Sunday afternoon, telling his wife he was tired and was going home to rest. He failed to return and his wife and daughter operated the restaurant until about midnight.

Mrs. Byerly and daughter then returned to their home and after searching the residence, found Byerly's lifeless body in the basement. He had placed the barrel of a shotgun in his mouth and fired the gun, the discharge blowing away the lower part of his head.
