## SAMUEL BLACK DIES SUDDENLY

Decatur Undertaker Dies Suddenly Late Friday Night at Home

S. E. Black, 62, prominent Decatur business man and veteran undertaker, died suddenly last night at 11:30 o'clock at his home on Adams street. Death was attributed to complications.

Mr. Black had been in failing health for the past six years but his condition was not thought serious. He was up and around Friday and apparently was not ill.

He retired about 10:30 o'clock last night, and some time later, members of the family were attracted to his bedside when he became ill. A physician was summoned but he

died within a few minutes. Mr. Black was born on August 15, 1877, a son of David and Mary Ann Weist-Black. He was married to Minnie Waltermire on April 30, 1897. In 1914 he came to this city from Portland. Here he entered the undertaking business

with M. J. Scherer, formerly of this city. In 1918 he purchased Mr. Scherer's interests and became the sole owner of the S. E. Black funeral home. His son-in-law, C. L. Weber, has been associated with him in the business since 1916. Mr. Black was a member of the First Evangelical church and fraternally was affiliated

with the local Masonic lodge, the Moose, Red Men and Knights of Pythias lodges. He was the last of eight children in his family. Surviving, besides the widow, are three daughters, Mrs. Weber, who has been associated with the funeral home with Mrs.
