DEATH CLAIMS AURORA MANN

Mrs. Harlo W. Mann Dies This Morning After Short Illness

Mrs. Aurora A. Mann, 63, wife of Harlo W. Mann, died at 8:45 o'clock this morning at the Adams county memorial hospital after a short illness of complications.

She was born in Decatur October 30, 1877, the daughter of Coat and Mary Bartling-Cook. She married Harlo Mann April 2, 1898. They live in Root township, four and one-half miles northwest of Decatur.

Mrs. Mann was a member of the Adams county choral society and formerly taught school in Preble township.

Surviving besides the husband are six children: Mrs. Florence Grossman of La Fountain, LeRoy Mann of Rosemead, Cal., Carl of Tocsin, Mrs. Louise Egan of Evansville, Wilson of Preble township, and Clifford, at home; three brothers: William Cook of Decatur, Charles A. and David of Decatur rural route; two sisters: Mrs. Ida Fisher of Paw Paw, Michigan and Mrs. Edith Singleton of Albion; and seven grandchildren. One daughter is deceased.

Funeral services will be Wednesday afternoon with time and place not yet arranged. The body was taken to the Zwick funeral home in this city.

The body will be returned to the residence from the Zwick funeral home Tuesday morning and may be viewed there after 2 p.m. until time for the services.

PIONEER COUNTY RESIDENT DIES

Mrs. Ernest Schlickman Dies At Her Home In This City

Mrs. Mary E. Schlickman, 73, pioneer Adams county resident and wife of Ernest Schlickman, died Thursday night at 7:30 o'clock at her home, 311 North First street. Death was attributed to complications. Her condition had been critical the past three days.

The deceased was born in Preble township July 20, 1861, the daughter of William and Fredericka Schraluka-Lammert. She had been a resident of the city for the past 35 years, having moved here with her husband from Kirkland township, where they resided 25 years.

They would have marked their 60th wedding anniversary next February. Mrs. Schlickman was an active and devout member of the Zion Evangelical and Reformed church.

Surviving besides the husband are the following children: August of near Bluffton; Mrs. John Williams, Mart Schlickman, Mrs. Dora B. Lawrie, all of Denver, Colorado; Mrs. Angie Macy of Decatur; a brother, William Lammert, of Decatur; six grandchildren. A daughter, a half-brother and two half-sisters are deceased.

Funeral services will be held Monday morning at 9:30 o'clock at the home and 10 o'clock at the Zion Evangelical and Reformed church. Rev. Charles M. Prugh will officiate and burial will be in the Decatur cemetery.

The body will be returned to the residence from the Zwick funeral home Saturday afternoon and may be viewed there after ? p.m. until time for the services.
