## Monroe Seaman Sees Action with Convoy Glen Ehram Gunner on Aircraft Carrier

Eight and one-half months ago Glen Ehram was just an average Adams County young man – one whose most exciting moments were probably those in the high school basketball game.

Much has changed in those few months, however for Ehram, who returned home this week for a few days visit with his parents, county surveyor and Mrs. William Ehram.

Glen is now a seaman in the U.S. Navy and a seaman with experience – not training experience, but actual combat experience.

Glen, who probably never expected to visit more than a few states to the Union, is now a world traveler to Africa, but take it from him, it was no pleasure cruise.

Like all men serving in Uncle Sam's forces, Glen didn't have much to say. He knew what he was permitted to say. This much he did tell:

He was assigned as an aerial gunner on an aircraft carrier, one of the nation's most valuable sea – signed, guarding the rear and dispatching its planes to protect the entire unit.

Seventeen "fish" – the seaman's word for torpedoes were fired at the aircraft carrier, but none found its mark, one narrowly missing it.

Now he is home on leave before going back to a naval base for a new assignment, and believe it or not he is "itching to bet back again."

## Charles D. Ehinger is Commissioned To Report Friday for Army Service

Charles d. Ehinger, secretary-manager of the Citizens Telephone Co., today was notified that he had been commissioned a second lieutenant in the signal corps of the U.S. Army and should proceed December 26, to Fort Monmouth, N.J.

The message stated that his orders and commission were being mailed from Washington having been signed by the adjutant-general of the Army.

Mr. Ehinger enlisted several weeks ago and has been expecting his call since the first of the month. He will report to the commanding officer of the electronics training group at Fort Monmouth.

Lieut. Ehinger is a graduate of Decatur High School and of Purdue University from which institution he was graduated in 1938 and received his B.S. Degree in electrical engineering.

Following the death of his father, Herman F. Ehinger, in August, 1938, Lieut. Ehinger was elected secretary of the Citizens Telephone Company in this city and later manager of the utility, positions which his father held for (cut off)

Medical Student Given Commission  
George Bierly, Jr. Appointed Ensign

He will transfer to the University of Louisville in Louisville, Ky., and will continue his studies until called to active service.

Ensign Bierly is a graduate of Decatur Catholic High School, taking up his premedic studies immediately following his graduation.

The commission was signed by James Forrestal, acting secretary of war, and was dated April 15.

Medical students are permitted to continue their studies and it is believed that Mr. Bierly will not be called to active duty at least until he enters his junior year at the university.
