C. M. ELLSWORTH DIES LAST NIGHT Well Known Decatur Man Dies Tuesday

Clarence M. (Jack) Ellsworth, 50 prominent garage proprietor and one of Decatur's leading citizens and business men, died last evening at the Adams county memorial hospital, where he had undergone an operation for a bowel obstruction a week ago today.

Hope was extended for his recovery and he seemed to be making satisfactory progress. He suffered a relapse yesterday, ending in his sudden death.

A son of J. Edward and Elizabeth Harkless Ellsworth, both deceased, Mr. Ellsworth was born in Decatur July 28, 1892. He attended the Decatur public schools until the family moved to Kansas and then to California.

He served four years, 1907 to 1911, in the United States navy and saw services with the Pacific fleet in the Solomons, in the Philippines and also in South American waters. He was in port in Hong-Kong, Singapore, Guadalcanal and other places now prominent in World War II. He was conversant with conditions in Pacific and Asiatic ports and was an ardent booster for the United States navy and its personnel.

Mr. Ellsworth returned to Decatur about 20 years ago. He established the Riverside garage on Monroe street, one of the largest concerns of its kind in the city.

The deceased was a member of the Zion Lutheran church, the Decatur Rotary club and the Adams county vigilantee association.

Surviving besides the widow, who before her marriage was Luella Conrad, are three children, Mrs. Viola Geiger, Columbus, O.; Mrs. Virginia Peal, Los Angeles, Calif., and Mrs. Mary Louise Needham, La Canada, Calif.

Five brothers and sisters also survive: Mrs. Nellie Myer, Exeter, Calif.; James Edward of this city; Mrs. Mae Stone, Glendora, Calif.; Leon W. and Fred F., both of Fort Scott, Kan. Mrs. Katherine Ellsworth, his stepmother, is living in Alhambra, Calif.

Funeral services will be held at 3:30 o'clock Friday afternoon at the Zion Lutheran church, with Rev. Paul W. Schultz, pastor, officiating. Burial will be in the Decatur cemetery.

The body will be moved from the Zwick funeral parlors to the Ellsworth residence, 320 Winchester street, Thursday morning, where it may be viewed until time of the funeral.
