LEVI SCHINDLER DIES EARLY TODAY OF BULLET WOUND

Fires Bullet Through Head Saturday Noon - Rites Wed. P.M.

Levi R. Schindler, 56, French township farmer and cider mill operator, died this morning at 5:30 o'clock at his home three miles west and a half mile north of Berne, from a self-inflicted bullet wound. With a .32 calibre bullet fired through his brain on Saturday noon, Mr. Schindler continued to live more than forty hours. Coroner Robert Zwick of Decatur, returned a verdict of suicide.

The community was greatly shocked Saturday afternoon when the report became current that Mr. Schindler had made an attempt to end his life. He had been in good health and was in normal spirits and his wife suspected his intentions as little as anyone. Mr. Schindler had been to Geneva and Berne Saturday forenoon on business matters and those with whom he mingled on his last trip to town, noticed nothing unusual about his conduct that would have suggested any rash intentions.

Schindler was to held one of his neighbors thrash Saturday afternoon and because of that fact he had requested an early dinner. His wife had prepared it for him and after dinner she went out to feed her chickens. From outside the house she called back to her husband, something about a light switch, but when there was no response she went in to take care of the matter herself. And, since Mr. Schindler had given no answer she went to see where he had gone. She was shocked to see him lie motionless on the bedroom floor and her first impression was that he must have suffered a heart attack. Even upon noticing blood about his face she did not think it was suicide because no gun was in evidence. Closer examination revealed a bullet hole in the right temple and in looking for the gun it was located under a dresser, under which it slipped when he fell. Schindler had made it a habit to keep his gun, a .32 calibre revolver, in his bedroom, loaded.

Entering his right temple, the bullet coursed slightly upward emerging above the left ear, and buried itself in the wall where the coroner recovered it.

A local physician was immediately summoned as well as the Yager ambulance. He was beyond medical help and since it was evident that it would only be a matter of hours until death, it was decided not to remove him to a hospital. He never regained consciousness.

The deceased was a son of David and Katherine Neuhauser-Schindler and was born in this

community on August 26, 1886. He was married to Miss Telsa Moeschberger on January 14, 1911. There were no children.

Surviving are the widow; his mother, who is making her home with her daughter, Mrs. Noah Rich north of Berne, and the sister, Mrs. Rich.

The body will be returned to the residence Tuesday noon, where friends may view it.

Funeral services will be held Wednesday afternoon at 2 o'clock from the Reformed church in Vera Cruz of which he was a member. Burial will be in the Vera Cruz cemetery. Rev. H. H. Meckstroth will officiate.
