She was a native of Monroe township and was born on the farm three and a half miles north-east of town where she spent almost her entire life. She was a daughter of William and Julia Jones-Harris and was born on January 19, 1865. Her father had purchased his farm from the government at \$1.25 an acre, and with the exception of several years which the Hendricks family spent in Colorado, she being the youngest child of the family remained on the farm until a few years ago, their age necessitated her and her husband to retire. They then moved to the present home on Behring street.

Before her marriage she spent a few winters as a rural school teacher in Monroe township.

Her marriage to Mr. Hendricks took place on January 13, 1887. He preceded her on December 15, 1939. To them was a born a son, Guy Hendricks, who resides at Arvada, Colorado, a suburb of Denver.
