Know all men by these presents that I Adam Healey of the County of
Lincoln and State of Kentucky for and in consideration of the sum
of eighty five dollars to me in hand paid by John Withers of the
County aforesaid the receipt whereof is hereby acknowledged and the
said John Withers and his Heirs of the same forever discharged have
granted bargained and sold, as I do by these presents grant bar
gain sell & deliver unto the said John Withers his Heirs and
Assigns one horse known by the name of Possum also a
blue roan mare branded T.R which I got of Luke Robertson To have &
to hold which I do hereby bind and oblige myself my Heirs Execs &
Admons to warrant and defend the same from the claim or claims
of any Person or Persons whatsoever In witness whereof I have hereunto
set my hand and seal this 25th day of August 1805

Henry Blagrave of the County of Campbell and State of Kentucky the
one part and Harrison Blagrave of the County of Mercer and State
aforesaid of the other part Witnesseth that for and in consideration of
the sum of ten pounds to him the said Henry Blagrave in hand paid
the receipt whereof he doth hereby acknowledge and the love and good will
I bear to my son Harrison Blagrave I have bargained and sold & by these
do great bargain sell and convey to the said Blagrave all my right title
and claim to and in one hundred and fifty acres of land lying in Camp
bell County on the waters of Pond Creek being part of Anthony Walton

(36) White Survey of 7000 Acres the place on which John Bolton formerly
lived and bounded as follows (to west) Beginning at a white Oak or a
white Oak is one of the corner trees and adjoining Esquire Great and
John Lippcomb with its appurtenances to have and to hold said tract of Land

Tiller aged Fourteen ten & Seven, which Negroes I do by these presents
acknowledge to be the property of said Compton and at his disposal with
their increase free from control by me or my Heirs forever as witness
