Coach Hammond and the team deserve great credit for the showing made under such unavoidable difficulties. Only four men were eligible for letters, Combs, Small, Webster and Miller. Prospects for next year's team are very favorable, since all the team members of '19 will again be eligible.

The Board of Control of Princeton High School was organized in 1912 under the direction of Principal McReynolds. It is the purpose of this board to direct and supervise all the student activities of the school.

The membership of the board is of such a nature that the pupils of the school to a very large extent manage their own activities with the proper supervision from the faculty. The board consists of a member elected from the Senior Class, one member elected from the Junior Class, and one elected from the Sophomore and Freshman Classes jointly. The three faculty members are elected by the student body without nomination by secret ballot, the three members of the faculty receiving the most votes being chosen. The Principal of the High School is an ex-officio member of the board, having no vote, but having full veto power.

The officers of the Board are a President, Vice-President, and Secretary, who are students, and a Treasurer, who is a member of the faculty. It is the duty of this treasurer to handle all money collected and expended in all the student activities.

This method of handling the activities of the school has proved very satisfactory in the eight years it has been in use.
