Crash claims Aker Fire chief was on motorcycle

Family members, friends and fellow firefighters are mourning the death of Portland's fire chief in a weekend accident.

Robert Matt Aker, 34, died at a Fort Wayne Hospital Saturday evening after the motorcycle he was driving collided with a car on West Votaw Street near Walmart.

"It's a whole lot of grieving," Portland Fire Captain Ron Somers said of the situation at the fire station today. "It's going to be quite a job to fill Matt's shoes. Everybody's trying to cope and get through it."

A large procession of fire trucks, patrol cars, rescue vehicles and an ambulance followed the van

carrying Aker's body from Parkview Hospital to Baird-Freeman Funeral Home, Portland, on Sunday evening. Some of those in the procession — including Jay County Sheriff's Office deputies and firefighters — cried as they drove down Meridian Street. Both sides of the street were dotted with mourners showing respect for the fallen chief. Communities north of Portland flocked to the sidewalks to show respect as well. Aker also served as the captain of the Jay County Sheriff's Office reserve deputies.

Funeral arrangements are pending at Baird-Freeman.

Aker, 1515 S. Meridian St., Portland, was pronounced dead at 5:51 p.m. Saturday at Parkview Hospital.

He died from multiple blunt force trauma, an official with the Allen County Coroner's Office said this morning. He suffered trauma to the head, chest and abdomen.

Somers said the Indiana State Police brought in a Critical Incident Stress Management team for firefighters Sunday — including those who had responded to Saturday's accident scene on West Votaw Street.

"We had a lot of hurt guys," Somers said. "It lets everybody vent a little."

Aker, a graduate of Jay County High School, was appointed fire chief by Portland Mayor Bruce Hosier in December of 2007. He had become a full-time firefighter in 2005 and had been a volunteer firefighter beginning in 1997.

His brother Chad Aker and father Mike Aker were also involved with the fire department.
