

WILL OF JENNIE BROTHERS

I, Jennie Brothers, of Crawfordsville, Indiana, do hereby make and publish this as my last Will and Testament, hereby expressly revoking any wills by me at any time made.

ITEM I.

I give to Dr. Fred A. Dennis, in payment and appreciation of his long and faithful service rendered me the sum of Two Hundred Dollars (\$200.00). I am especially grateful for his indulgence in carrying me without compensation.

ITEM II.

I give to Dr. John H. Beeson the sum of Fifty Dollars (\$50.00), in payment and appreciation of his services rendered me; and I am likewise especially grateful to him for having indulged me for a long time without charge. And I desire to express my appreciation for the great kindnesses, also, shown me by both Dr. Dennis and Dr. Beeson.

ITEM III.

I give to Mrs. James H. Layton, of Crawfordsville, Indiana, my large mirror, and my bed and bedding.

ITEM IV.

I give to Mrs. Anna B. Thompson, of Crawfordsville, Indiana, My China Cabinet.

ITEM V.

I desire that Hattie Pursel, Mabel Thompson Smith and Ottis O. Thompson, take charge of my funeral and burial arrangements on my death; and I contemplate leaving a memorandum or writing with or for them or with my executor, or with my will, indicating my wishes as to disposing of various small articles of clothing, ornaments and effects about the household to various persons I may want to remember; and these three persons will attend to distributing such articles. All the rest and residue of my property of every kind and nature, subject to the payment of my debts and the liabilities of my estate, I give, devise and bequeath to Ottis O. Thompson. I do not anticipate there will be any substantial residuary estate; and I have advised him what I wished done with

any such portion; and will leave a memorandum in writing and directions as to apportioning small sums and items to various friends and parties I wish to remember; and I know that he will carry out my wishes.

VI.

I nominate and constitute Ottis O. Thompson, as Executor of my will; and authorize him to distribute the items in the last above paragraph as he and the other two persons may be directed by any writing other than this that I may leave; and he will in all things administer my estate; provided, that should Ottis O. Thompson not be living at my death, or be unwilling to serve; then his daughter, Mabel Thompson Smith will serve as executrix.
