WILLIAM McCORMACK Probate Record - Montgomery County, IN
A Complete Record of the Administration and final settlement of
the Estate of William McCormack deceased, commenced in the
Probate Court of Montgomery County in the State of Indiana and
completed in the Court of Common Pleas of said County**

**To Wit: William McCormack's Estate. Burel McCormack,
Administrator. Be it remembered that on the twenty fifth day of
September in the year Eighteen Hundred and fifty one in vacation
of the Probate Court of Montgomery County in the State of Indiana,
Burel McCormack appeared before the Clerk of said Court and took
and subscribed an affidavit which was filed and is in the words and
figures To Wit: The State of Indiana Montgomery County Set.
Personally appeared before me Andrew P. Lynn, Clerk of the
Probate Court of Montgomery County, Burel McCormack of lawful
age who being by me duly sworn upon his oath saith that William
McCormack an inhabitant of said County, at the time of his death,
departed this life in the County of Montgomery aforesaid without
leaving a Will as he is informed and believes to be true. On the 28th
day of August 1851. That said William McCormack left personal
state in said County to be administered to the value he is informed
and believes of not exceeding Three Hundred and fifty Dollars, and
that he is a Son and heir at law of said dece of lawful age and
entitled to share in the distribution of decedents Estate. (Signed)
Burel McCormack X (his mark) In witness of which I hereunto set
my hand at Crawfordsville this 25th day of September A.D. 1851.
A.P. Lynn Clerk And thereupon said Burel McCormack made
application to said Clerk to be appoints Administrator of the Estate
of said decedent and the said Burel, being a competent person said
Clerk appointed him Administrator of the goods, chattles, rights,
credits, moneys and effects, which were of the Estate of said
decedent at the time of his death, and the said Burel before
receiving Letters executed a Bond herein, which was filed, and is in
the following Words, and figures To Wit: Know all Men, that we
Burel McCormack and Thomas Brenton, of the County of
Montgomery in the State of Indiana are held and firmly bound unto
the State of Indiana in the sum of Seven Hundred dollars, to the**

payment whereof will and truly to be made and done, we hereby bind ourselves our heirs, ancestors or administrators, jointly severally and firmly by these presents, signed and sealed by us, and dated this twenty fifth day of September A.D. 1851. The condition of the above obligation is such that if the above bound Burel McCormack shall diligently and faithfully execute the duties and trust committed to him as Administrator of all and singular, the goods, chattles, rights, audits, monies, and effects, which were of William McCormack late of said County of Montgomery. Deceased, as forescribed and required by law, and will obey all orders and decrees of the Probate Court of Montgomery County, made pursuant to law, touching the Administration of said Estate, otherwise to be and remain of full force and virtue.

Lynn Clerk Thereupon said Clerk granted and issued Letters of Administration to said Burel McCormack on the Estate of said decedent which is in the words and figures To Wit: State of Indiana Montgomery County, I Andrew P. Lynn Clerk of the Probate Court, in and of the County of Montgomery in the State of Indiana, do hereby certify

that Administration of the goods, chattles, rights, credits, moneys and effects which were of William McCormack late of Montgomery County, deceased, who died intestate is granted to Burel McCormack and the said Burel McCormack, having qualified and given Bond as such Administrator, is duly authorized to take upon himself the Administration of such Estate according to law Witness my hand and the seal of said Court, this twenty fifth day of September, in the year of our Lord One thousand eight Hundred and fifty one. A.P. Lynn Clerk And afterwards To Wit: On the tenth day of November in the year Eighteen Hundred and fifty one, it being the first judicial day of the November term of said Court for said year and before our said Judge. The Clerk of said Court made a written report of Letters of Administration granted by him during the last vacation of said Court among which the following was reported To Wit. Letters of Administration granted to Burel McCormack on the Estate of William McCormack, deceased, with Thomas Brenton his surety in a penalty of \$700.00. And the granting of said Letters as reported was ratified and adopted as such of the Court, and the ratification and adoption thereof was recorded in the Order Book of said Court. And afterwards

To Wit: On the twenty first day of February in the year Eighteen Hundred and fifty two, this cause was continued. And afterwards

To Wit: On the tenth day of December in the year Eighteen Hundred and fifty two, in vacation of the Court of Common Pleas for said County Burel McCormack, Administrator of the Estate of William McCormack, deceased, appeared and filed in the Clerks Office of said Court the Oath of Appraisers, Inventory, and Sale bill, and reads in the words and figures following To Wit: State of Indiana Montgomery County, Set. We Aaron R. Schenck and Leroy Bradley, solemnly swear that we will make a just and true valuation and appraisement of the goods and effects of William McCormack, deceased, so far as they shall come to your knowledge. To Wit: On the seventh day of October in the year Eighteen Hundred and fifty three, it being the fifth judicial day of the October Term of said Court, for said year and before our said Judge, Comes said Administrator and files his petition verified by Oath in vacation of said Court

To Wit. On the 11th day 1853, asking an order of said Court to sell and transfer Land Warrant No. 923 of the date of the 11th of February 1851, for 80 acres issued under Act of Congress of the 28th of September 1850, in the name of said William McCormack, Private in Captain Yearlys Company Colonel Dickinsons Reg. Virginia Militia, War of 1812 who has deceased, since the issuing of said Warrant, setting forth among other things that the personal Estate of said William McCormack is insufficient to pay off the indebtedness of said McCormack, and that he left as his surviving heirs Allen McCormack, Anderson McCormack, Burel McCormack, George McCormack, William McCormack, Thomas McCormack, Julia Ann Fisher, Polly Wade, Johnson McCormack and James McCormack. Proof being made that notice by publication was given, thirty days before the first day of this term, to said heirs, and the Court being satisfied that said William McCormack was the owner of said Warrant in his lifetime and that he deceased since the issuing of said Warrant, and that the above are his legal heirs under the laws, of this State, and that said Warrant ought to be sold as asked for by said petitioner. It is therefore considered that Burel McCormack said Administrator sell at private sale, and transfer all right, title, and claim which the said William McCormack owned in his lifetime, together with all the right, title, interest and claim of the said heirs, in and to said Warrant, and that he be authorized to make said sale assignment, and transfer in the manner and to the effect as prescribed by law, and that said transfer when made shall vest in the purchasers a right to transfer over or locate said Warrant in the same manner that said William McCormack could have done in his lifetime. And afterwards To Wit: On the eleventh day of January in the year Eighteen Hundred and fifty nine it being the ninth judicial day of the January term of said Court for said year and before our said Judge, Burrell McCormack, Administrator of said Estate, appears and files an account current and accompanying vouchers for a final settlement of said Estate. Which said account, current is examined and confirmed by the Court and reads in the words and figures following To Wit: To the Honorable Court of Common Pleas of Montgomery County, Indiana, Burel McCormack, Administrator of the Estate of William McCormack, deceased, would respectfully represent that there has come into his hands and he has made the following disbursement thereof. To Wit: Amount of Sale bill 420.07 And has paid out as follows: Voucher No. 1 J.P. McGilliard Guardian 150.00 Voucher No. 2 J. Ellis for coffin 12.00 Voucher No. 3 G. McCormack attention to

property 2.17 Voucher No. 4 Thomas McCormack attention to property 12.50 Voucher No. 5 A. Kelly Doctor Bill 16.50 Voucher No. 6 A. Skenk Appraiser 1.00 Voucher No. 7 L. Bradley Appraiser 1.00 The above account current is correct in all things as I verily believe. Burel McCormack X (his mark) Subscribed and sworn to before me the 10th day of January 1859. Wm. C. Vince, Clerk Which said account current and settlement shows that said Administrator has paid out the sum of Nineteen Dollars and twenty seven cents, more than come into his hands by virtue of his said trust. Therefore said Administrator is discharged from any further duty respecting his said trust. And thereupon it is ordered that the Clerk of this Court make a completion record of all the proceedings in this case.
