## SUICIDE IS RULED IN SHOTGUN DEATH

CELINA -- Mercer County Coroner R. Duane Bradrick has ruled the death of Kenneth Hoblet, 55, of Chattanooga, as suicide. Mr. Hoblet was shot in the head with a .410 shotgun in the garage of his home at 5:25 a.m. today. His wife, Gertrude, heard the shot and found the body.

The coroner said Mr. Hoblet, a self-employed auctioneer, had been despondent and under a doctor's care.

Mr. Hoblet was born in Adams County, Ind., May 17, 1908, to John and Olive (Pinkam) Hoblet. His mother survives. Also surviving are his wife, Gertrude; six daughters, Mrs. Lester (Sandra) Strickler, Willshire; Mrs. Gene (Linda) Michaud, Rt. 1, Willshire; Mrs. Sam (Nita) Hellworth, Rt. 1, Celina; Dana, Carla and Myra, all at home; a sister, Mrs. Ethel Bebout, Willshire and seven grandchildren. He was preceded in death by his father, two brothers and his first wife, Bessie Strickler, who was killed in an automobile accident.

Mr. Hoblet was a member of the E. & R. Church in Liberty Township and the Moose Lodge in Celina.
